

## **Sponsorship offer : Regulation**

### **Article 1 - Promotion organiser**

Homebrella (referred to below as “the organizer of the promotion”) is a trademark of ADMIRAL INTERMEDIARY SERVICES SA.

AIS SA is an indirect subsidiary of Admiral Group plc ([www.admiralgroup.co.uk](http://www.admiralgroup.co.uk)). The registered office of AIS SA is located at Calle Albert Einstein 10, 41092 Seville, Spain. The company is authorized to operate in mainland France and is registered with Orias ([www.orias.fr](http://www.orias.fr)) under the number AJ-0213. AIS SA is also registered at the Lille Métropole trade registry under the number 842 188 310. AIS SA is domiciled at 9-10 Rue de l'Abbé Stahl, 59700, Marcq-en-Barœul.

The organiser of the promotion offers a promotion from 12/01/2020 to 12/31/2020 which conditions are described in this document.

### **Article 2 – The sponsorship offer**

The sponsorship offer is intended for Homebrella customers and aims to reward their engagement when they inspire people to become customers of Homebrella. To benefit from the promotion the sponsoring client must have a current home insurance contract without default of payment. The sponsorship offer allows the client of Homebrella to sponsor maximum 5 people per year. The sponsor is then reimbursed of 15 (fifteen) euros by sponsorship by transfer to their bank account within 30 days of using the code; The sponsored party benefits from a promotional code of 10 (ten) euros if the sponsored party contract is successfully taken out. The sponsoring client must have a home insurance contract in progress, not suspended or terminated when subscribing to the sponsored party's contract to benefit from the promotion.

To benefit from the offer, the estimate must be started and finalized on the website of Homebrella. By participating in sponsorship of Homebrella, the sponsoring client and the sponsored party undertake to accept without reservations the provisions of this regulation. Homebrella reserves the right to shorten, to suspend, to modify or terminated the sponsorship operation at any time, especially in case of major force without its liability being incurred. These changes will be subject of prior information by all appropriate means, especially on the site [www.homebrella.fr](http://www.homebrella.fr).

### **Article 3 – Duration of the offer**

The sponsorship offer is 15 euros for the sponsored client and 10 euros for the sponsored party it is valid from December 1, 2020 until December 31, 2021.

## **Article 4- Operation**

The customer who will already have a current home insurance contract and without default at Homebrella will be able to sponsor a person. The person who wants to be sponsored must make an online quote and complete the subscription to your home insurance contract on the Homebrella website. During his contract subscription, the sponsored party must be able to communicate the promotional code of his sponsor. The reward will be collected by the sponsor client and the sponsored party when the subscription of both contracts will have been validated by Homebrella. If the sponsor terminates his home insurance contract before the sponsored party contract has been validated, the sponsor will not be able to pretend to the reward. The sponsor and the sponsored party if the sponsored party terminated before paying first monthly installment if it is monthly. Sponsorship offer is valid only once for sponsored party during subscription. The sponsor can be rewarded for referrals up to 5 times over a period of one year from the date of the first sponsorship. Once the one-year period is over, the sponsor can again claim 5 rewards over one year from the first sponsorship of the period.

## **Article 5- Conditions of eligibility**

To participate at this offer, the participant(s) must meet the following conditions:

- The sponsored party must not have gone through a price comparator to make his quote.
- The sponsor and the sponsored must be a physical person aged 18 and over, -The sponsor must have at least one insurance contract in progress in Homebrella as the subscriber of the contract designated at the time of signing the sponsored contract. -The sponsor must be up to date in the payment of his insurance contribution for initial contracts. – The sponsor can be an employee of Homebrella provided it meets the above conditions. The sponsor cannot self-sponsor. A sponsored and a sponsor must have a different customer account number, last name, first name and email address. -If a customer has already benefited from sponsorship once, he cannot benefit from it a second time.

As part of a termination made at the request of the insured (godson) during the first year following the subscription:

- In case of an annual subscription: The termination by the insured will result in the deduction of the amount of the promotion (10 euros) from the portion of the contribution to be returned by the insurer corresponding to the period from the effective date of the termination on the initially scheduled expiry date.

- In case of monthly payment: termination by the insured will result in the said promotion deducting 10 euros from the portion of the contribution to be returned by the insurer.

## **Article 6 – Nature of the offer granted to the client**

Homebrella will offer those who meet the conditions required a refund of 15 euros for the sponsoring client and a promo code for the sponsored relative who become a sponsored party. The refund will be made to the sponsor's bank account once the subscription file is complete within a maximum of one month from the validation of the sponsored file. For people who have chosen the monthly payment, the reimbursement will be made after the payment of the first monthly payment, within a maximum period of one month from it.

### **Article 8 - Litigations and relevant courts**

Any litigation that may result from the interpretation of these sponsorship regulation will be submitted to Homebrella first and as a last resort to relevant courts in Paris.
